In Memoriam

Marvin w. Roth— January 22, 1923 - July 6, 2003

Marv was born in Janesville. He graduated in 1940 from Janesville High School and attended the UW School of Engineering. Later he worked at GM in the Engineering Department. In 1943 he took a leave from GM to join the US Army where he served for 3 years. He received a Purple Heart for service in Europe. Prior to overseas duty Marv married Betty Ann Kuebil on Feb 13, 1943. They celebrated their 60th Anniversary this past February. Marv was very active in the business world. He worked at Roth and Holdorf Contracting Co, becoming sole owner in 1963. He was elected President of the Rock County Builders Association. By 1970 Marv began working as an estimator and fieldman for T.S. Willis, a Janesville contracting business. He served as a Janesville City Councilman from 1967 - 73. In 1975 he became Executive Director of the Greater Janesville Corporation and Executive Director of the Janesville Chamber of Commerce [Forward Janesville]. He served the latter 14 years. When Marv announced his retirement from the chamber, he accepted the title of "Mr. Janesville." Marv was very active in the American Legion Post 205, serving in many positions and on numerous committees over the years. He was very active in Kiwanis International, serving in several positions in the Noon Club and the Blackhawk Golden "K" Club. He also served as Lt. Governor of the Wisconsin and Upper Michigan District of Kiwanis. Marv and his wife Betty were charter members of St. John Vianney church in Janesville. He was a commentator and active on many church committees over the years.

Marv is survived by his wife and 9 children, numerous grandchildren and great-grandchildren. Funeral services were held July 10, 2003 at St. John Vianney Roman Catholic Church. Interment was in Mt. Olivet Cemetery.

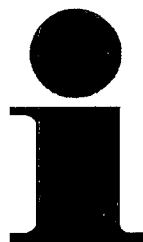
