





**IMPORTANT CLUB BYLAW INFORMATION**

The officers of this Club shall be a President, Immediate Past President, 1<sup>st</sup> Vice President, 2<sup>nd</sup> Vice President, Treasurer, Assistant Treasurer, Secretary, and Assistant Secretary.

The Board of Directors shall consist of the officers and 5 elected Directors. The Board of Directors shall meet regularly at least once each month.

A quorum of the Board of Directors shall be a majority.

At the Feb 25, 2004, Board of Directors Meeting 5 of the Board members were in attendance, **not** a majority. Therefore the Board could not legally carry out its duties. This is a very damaging situation for our club to be in.

Some important actions have to be taken soon. The Annual Meeting of this club shall be the 3<sup>rd</sup> Regular Weekly Meeting in April. [As required by the bylaws of Kiwanis International, the Annual Meeting of a club shall not be held earlier than the first meeting in April and not later than the second week in May]. The club membership shall be given at least two [2] weeks' notice of the date and place of the Annual Meeting.

The election of Officers and Directors shall be held at the Annual Meeting.

At a Regular Meeting of the club at least five [5] weeks prior to the date of the Annual meeting, the President shall appoint a Nominating Committee consisting of five [5] members.

The duties of this Committee shall be to make nominations, with the consent of those nominated, and to prepare a ballot for election of such Officers and Directors.

Gentlemen, long-term absences are hurting our club. As stated above, the full Board of Directors has many important topics to consider. Let's all put our oar in the water and get this ship going on an even keel.
