





## TREE SALE SUMMARY

Tree sale results this year were dismal. The old adage that time and hard work pays off was not the case for our financial outcome this year. Club members put in over 550 hours with a return to the Golden "K" of \$444.64.

Tree sale planning started in November with monthly meetings through March. Three deciduous and two evergreen species were added this year with a total of 12,000 trees ordered. Financial Summary:

**\$9,914.69 Total revenue**

**\$9,025.31 Total expense**

**\$889.28 Net Profit**

Unsold trees were donated to the Janesville Schools, Camp Rotamer, Boy Scouts, Milton Schools, and the City of Milton.

I wish to thank all of the club members and Rotary Gardens staff and volunteers for their time and energy. This is a major undertaking which requires much time, effort and support and as we saw this year, no guarantee of financial success.

Called to order at 8:33am by President, John Janes.

No Secretary's Report.

Treasurer's Report, 5/30/12 was distributed and discussed. Will Reck explained the financial positive and negative picture of our recent fundraising activities. Truck-On-Ice was positive, Tree Sale was negative. He proposed the transfer of \$1,200 from the Service Account to the Administrative Account to cover the disbursement of funds to pay our obligations. A motion was made, seconded, and carried to accept the treasurer report.

### Correspondence:

- Bag Haiti's Hunger - John Janes reported that the collection raised \$319 for the cause. Discussion followed about the feeling of membership regarding collections at Golden "K" meetings and the general consensus was positive.

### Old Business:

- Summer Fundraiser: John Janes said he thought it was too late to get anything going for the 4<sup>th</sup> of July.
- Hixson Award: Will Reck reported that the Golden "K" Club donated \$3,000 to Project Eliminate which will qualify us for 3 Hixson Awards.

### New Business:

- Flags for Retirement: Dave Soderberg requested \$18.75 of the budgeted \$50 to cover the expenses for the Flag Retirement Ceremony. A motion was made and seconded to distribute the funds and was accepted.
- Membership Growth: John Janes talked about a goal of increasing membership by 20% which hasn't been met, and expressed concern about the lack of growth. A discussion about the annexation of the Milton Club Members and the possibilities of allowing women membership in the club to increase our numbers followed.
- Pier Project: Ben Coopman from the Noon "K" Club proposed a joint venture 50/50 deal for improvements on the pier project asking for financial assistance. Discussion will follow at a later date after a written proposal is submitted.

### Additional Items:

Glenn Disrude:

- Submitted a financial report on the tree sales with recommendations for the future of this project.
- Suggested an activity calendar that shows manpower commitment of our fund raising activities. This may help avoid a bunch up in certain months and prevent burn-out from our volunteers.

Meeting adjourned at 9:20 am.
