





Meeting was called to order at 8:30 a.m. by President John Janes.

Secretary's Report:

We discussed the annual dues forms that need to be turned in to Will Reck by 09-19-12. Also discussed was the obtaining of information for ordering pins and certificates. (*New officers, legion of honor, perfect attendance etc.*)

Treasurer's Report:

Report dated August 27, 2012 was distributed and discussed. Will Reck reported on the success of the recent peanut day fundraiser and after expenses, there was a net profit of \$4,045. That total will be updated when all remaining peanuts are sold and final expenses tabulated.

Old Business:

- **Kiwanis Pond Pier:** The Noon Kiwanis Club has asked for financial assistance regarding the pier project. Since this was not budgeted for, the board decided to table the motion of helping to fund this project. Significant sweat equity on the part of Golden "K" was our contribution and future talks with the Noon Club will be ongoing.
- **Banners for Events:** We discussed looking into the cost and what kinds of Kiwanis banners would be useful to the club.
- **Summer fundraiser:** We discussed ideas regarding a second summer fundraiser in addition to peanut day next year. The 4th of July period was suggested while we still have the manpower before winter leaves us shorthanded.

New Business:

- **Air Conditioner for Sons of Norway:** The air conditioning unit needs to be replaced. To help out with this need the board made a motion to help out financially and the motion was unanimously approved.
- **Booth at Farmers Market:** John Janes suggested that next year we set up a booth to gain more visibility, recognition and possibly help with recruitment by informing the public of what we do in the community and answer questions people may have about us. How often we would do this has yet to be determined.
- **Women Members:** Ideas and further discussion about getting women members into the club were generated and will continue to be an ongoing topic. The board unanimously decided that it would be a good idea to encourage women to join and how it could help us out in so many ways.
