







Call to order: at 8:27 a.m. by President Carl Cramer. The agenda was approved.

Secretary's Report:

Reviewed a correction to the minutes regarding officer elections. The minutes from the 10-31-2012 board meeting were accepted as printed in the November Smoke Signal.

Treasurer's Report:

Financial statements from 11/26/2012 were distributed and discussed. Will Reck expressed concern about the administrative account shrinking to \$910.00 and the challenge to stay in a surplus. Discussion followed on ways to cut expenses and raise additional funds. Motion to file the Treasurer's report as presented was made by Will Reck and accepted.

Correspondence:

Letter of appreciation was sent to the company that made the Kiwanis Banners and a letter was received from the Sons of Norway in regards to the \$1,000.00 donation for the air conditioning unit.

Old Business:

- **Board Policies for 2012-2013:** All 19 policies except 17 and 19, (*which were already approved*) were read, discussed and voted on. Policy 12 will be adjusted to reflect the new financial status with dues. It was decided to eliminate from Policy No. 13 the option of fresh flowers sent to the funeral home of a deceased member and instead replaced with a donation to the Kiwanis International Foundation in the name of the deceased members family. It was felt that the money spent would do more good.
- **Official Club Documents:** A need to find the club Constitution and Articles of Incorporation was expressed by President Cramer.
- **Membership Drive:** President Carl Cramer talked about the December 5th membership drive and that

Pete Kealey would be addressing the members at our meeting today.

- **Letter from Janesville Kiwanis:** A letter was received from the Kiwanis Noon Club about a bill from the city for Kiwanis Pond pier repairs in the amount of \$4,500.00 over a two year period. It was discussed once again that our intent was to enter into this project with sweat equity instead of money since we just don't have it and are under no legal obligation to pay. A communication to this effect will be sent to the Kiwanis Noon Club.
- **Approval of the 2012-2013 budget:** It was approved with the understanding that the budget needs to be flexible due to circumstances and cash flow.
- **Consider Club Bylaws:** It was discussed that the bylaws must be okayed yearly and then signed and submitted.

New Business:

- **Possible Club Meeting:** It was approved to hold our meeting on Wednesday, January 2, 2013.

Meeting adjourned at 9:19 a.m.
