







Secretary's Report:

Secretary's Report: The minutes from the 11-28-2012 board meeting were accepted as printed in the December Smoke Signal.

Treasurer's Report:

Financial statements from 12/17/2012 were distributed and discussed. Since there were no financial disbursements for December, a motion to file the Treasurer's report as presented was made by Will Reck and accepted.

Old Business:

BLACKHAWK GOLDEN "K" KIWANIS**


(A world leader in thin, slippery ice technology needs you)

BE REMINDED THAT THEY DO CARE ABOUT OTHERS.**

QUALIFICATIONS

- 1) Must be able to smile and say "Hello, I have an opportunity for you to win \$3,000 and help our kids."
- 2) Must be able to say "Thank You"
- 3) Must be able to count to 20 (no fractions)
- 4) Must be able to sit or stand for 2 hours with your eyes open.

BREAKING NEWS UPDATE

"The ice isn't thick enough! You won't be able to get the truck out there"
We hear that every year and sometimes they are right.

There are two problems when the winter is mild. The first is that the water along the shoreline doesn't freeze. The second problem is that the ice must be thick enough to support 15 or twenty of our members that are needed to pull the rope that moves the truck onto the ice. This is one and one-half tons of weight on the ice in addition to the truck.

Our TOI committee, plus Maury Frey & John Janes, has been working on these problems. Maury suggested we use a crane when the ice is thin. This is an exciting concept. It would be safe and garner a lot of publicity when putting the truck on the ice. The problem is how to reinforce the attachment of the truck body to the frame and be sure the wheels don't fall off. We are working on a solution. Mark Cullen of J.P.Cullen has agreed to furnish a soft tired crane with a ninety foot boom if needed.

The second idea is to launch the truck from the south end of the lagoon where the shoreline ice is usually thick. We would use a snowmobile driven by a good swimmer. This idea doesn't dramatize the event the way the Crane would. The good news is it would keep almost a ton of weight off the ice when putting the truck out onto the ice. At this point we are assuming that a retailer of snowmobiles would pull the truck out onto the ice for us if we need to follow up with this plan.

A third idea is not to worry about the ice thickness and just have the Aqua Jays pull it out for us since they are all good swimmers.

The point is that you can use these ideas or concepts when you are selling guesses. We do not know if we will use our traditional way of launching the truck or if will use a crane or a snow mobile. It all depends on the how cold the winter will be and what we can get done. It is probable that we will be putting the truck onto thinner ice one way or another.
