







Call to order: at 8:31 a.m. by President Carl Cramer.

Quorum was present. Agenda was approved.

Secretary's Report:

Treasurer's Report:

Presented by Treasurer, Will Reck. A small amount of activity in our accounts has occurred this month. We have surpassed our fund raising goals and are within our budget limits. One student scholarship for a UW-Rock County student has been delayed for a few months at the student's request. The financial report was accepted.

Correspondence:

Old Business:

- Deceased Members Plaque: We are awaiting an update from our Secretary, Paul Neitzel, about the new plaque for deceased members.
- Financial Review: We discussed our handling of cash during fund raisers as recommended in our recent Financial Review. The view was expressed

that we have improved. Specifically, we use sealed donation containers for K Peanut Day and Lily Day. Our other fund raisers seem to be just too large in scope to handle in a similar manner. Counting of the incoming funds is done primarily at a bank with automatic counting machines. We will continue to try to improve in this area.

- Breakfast Club: With changes in the Breakfast Club for Students, we discussed how we should adjust our support. We still have a few people helping at schools but most have stopped. Our financial support will be redirected.

New Business:

- Deceased Members: A proposal to honor recently deceased members with a framed certificate was discussed. We will incorporate this new practice in our Board of Director Policy Number 13. Gordon Drake had prepared some certificates and Carl C. will make them ready for presenting to the appropriate families.

- International Convention: Attending the Kiwanis International Convention in Vancouver, B.C., June 26-29, will be President Elect Glenn Disrude and District 3 Lieutenant Governor Gordon Drake. Carl C. had planned to attend but now has important family travel plans that interfere with the Conference, and will not attend.

- Mid-Winter Conference: Attending the WI/UP Kiwanis Mid-Winter/Mid-Year Conference in West Bend, Wisconsin, April 6 will be Pres. Carl Cramer, Pres. Elect Glenn Disrude, Lt. Gov. Gordon Drake, Noon Kiwanis members, and maybe others. We will car pool.

- Membership: Club membership and growth was discussed. Improved public relations in the form of newspaper announcements of meetings will be pursued.
