







Secretary's Report:

Submitted as published in the December Smoke Signal with no changes and approved. After the Board approves the minutes as distributed in the Smoke Signal, we will keep a signed copy of the minutes in a binder for all members to refer back to.

Treasurer's Report:

Our WI-UM Kiwanis District past Governor Lynn and Merita Messer are passionate about helping children on the Autism Spectrum learn and communicate. Their granddaughter, Kelsey, was diagnosed with Autism Spectrum Disorder at the age of eight. It has been proven that autistic children benefit from the use of software Apps available for the Apple® iPad. Governor Messer's goal is to raise over \$500,000 to be used to furnish iPads, Autism software Apps and protective cases for at least 1,000 children on the Autism Spectrum in the WI-UM Kiwanis District.

Our club provided iPads for 4 of the 6 Autistic children who received iPads in Janesville. President Glenn Disrude and Past President Carl Cramer thanked the Board and received an award of appreciation from the Board of Education at the meeting on December 10. A couple of families receiving the iPads were at the board meeting and expressed their appreciation to Kiwanis.
