





Call to order: 8:30 by President Glenn Disrude

Secretary's Report:

The Secretary's Report was seconded and unanimously approved.

Treasurer's Report:

Will Reck discussed the disbursements of \$400 to the Kiwanis District Foundation; \$3,000 to the Blackhawk College Scholarship Fund; and \$1,000 collected for Project 16:49, from the members at the March 19 meeting. The Treasurer's report was seconded and approved.

Old Business:

Truck On Ice Ticket Sale Discussion:

Pete Kealey discussed the possibility of working with the Downtown Improvement Alliance to potentially increase the ticket sales and publicity of the Truck On Ice event and he is seeking approval from the Board of Directors to propose this to the D.I.A. There was discussion on how this might work and some of the obstacles and concerns from the Board. A motion to allow Pete to propose this idea to the D.I.A. was made, seconded and approved.

Web Site Discussion:

Glenn Disrude in conjunction with Dave Peterson handed out a Web site Guidelines/Improvements paper to the Board. There was discussion about what should or shouldn't be on our web page. There will be further discussion after the Board and membership have time to review the guidelines and spend some time reviewing our web page content.

Financial Review Report:

Glenn Disrude discussed the need to review the committees recommendations and to provide a written response to the recommendations from the Financial Review Committee. He reviewed some of the recommendations regarding the collection and handling of money collected from various fundraisers. Also, board members were asked to bring their responses regarding the recommendations to the next board meeting.

Hixson Awards:

Glenn Disrude asked if there were club requirements, other than financial, for receiving the Hixson Award and Will Reck confirmed that we qualify for issuing 3 awards based on our contributions to the Kiwanis International Foundation. Two board members have asked about issuing the Zeller Award for funds contributed to Kiwanis International Foundation for Project Eliminate as recommended by Kiwanis International.

New Business:

Sons of Norway:

Discontinued land phone line. Membership needs to make arrangements for outgoing and/or incoming calls.

Traxler Park Sign:

There was discussion about providing a donation for a new Traxler Park Sign and how much to donate. A motion was made and seconded to have Glen Jablonka discuss how the sign would benefit our club and how we could use the sign to promote Truck on Ice activities with Tim Cullen of the Rock Aqua Jays. A maximum \$500 contribution from our club was recommended. The motion was carried.

Other Items:

Carl Cramer talked to the Board about Insurance for the club so that Membership is covered while on duty during Kiwanis sponsored events.

The program is a war veteran remembrances.




EDISON BUILDERS CLUB
