









Secretary's Report: Paul gave an update on the deceased members plaque and stated that it should be completed and available for pick-up very soon. The minutes were approved as published.

Treasurer's Report: Will reported that he received a check for \$300 from the Pontiac Convention Center Christmas Tree Competition that Ron Shuler entered on behalf of the Blackhawk Golden K Club. Will also stated that the club received a one time \$1,500 contribution from one of our members to be used as a scholarship for one Parker H.S. student. Will made a motion that the financial report be filed as submitted and was seconded by Dave Peterson and approved.

Club Correspondence: Governor's Project – Golf Cart

The Governor's Project is a request for \$12,000 to acquire a 6 person golf utility cart to be used at Camp Waubek. Our club has budgeted \$100 for this project.

OLD BUSINESS:

Appeal Letter Status – Maury Frey. This years appeal letter raised \$2,953 for the Administrative Account.

Kiwanis Park Proposal – Tabled

Recommendation to cover expense for new member sponsor: Carl Cramer recommended the Board of Directors approve the additional expense of covering the orientation breakfast for the sponsor of a new member as well as the committee chair and prospective new member. Lon Coppernoll made a motion to approve this recommendation and it was seconded by Will Reck and approved. Dave Peterson suggested we update Board policy regarding this matter at the next Board meeting and it was agreed by the Board to do so.

Budget Discussion:

Motion by Dave Peterson: **Move the Eliminate Project revenue and disbursement line items from the Service Account to the Administrative Account.** Richard Johnson seconded the motion and after some discussion from the Board about the allocation of money collected locally to remain for local purposes only, the motion did not carry.

Motion by Dave Peterson: Add Umpire Training as a disbursement in the Service Account with a budget amount of \$1,000 for the current year: Lon Coppernoll seconded the motion for discussion. We traditionally donate \$500 annually to the Boys/Girls Club. After some discussion, the Board settled on an additional amount of \$500 as a separate donation to specifically go towards the Umpire Training Program. Richard Johnson made a motion to approve this amount and Carl Cramer seconded it. The amendment was approved.

Motion by Dave Peterson: Lower the budget amount for the Miscellaneous Account in the Service Account to \$1,000. Discussion centered on the high balance listed on the books at the end of the fiscal year due to timing and therefore not necessary to change policy. There was no second to the motion.

NEW BUSINESS:

Request of Program Committee to present local Muslim leader's information session on local Mosque:

The Board agreed to leave it up to the Program Committee to decide programs instead of having to have Board approval.

Request the approval of new member.

Carl Cramer presented information to the Board on behalf of accepting Curt Nodolf into the club as a new member. Lon Coppernoll made a motion to approve the new member and it was seconded by Will Reck and unanimously approved.

Camden Playground:

Ron Shuler brought up for discussion the idea of a one time donation of \$4,001 as an added expenditure which would lead to a matching grant. We currently promote Camden Playground as one of our projects during the Truck on Ice fundraiser. Although a dollar amount has yet to be determined for this project, some members of the Board felt that this amount was too high.
