





### **Secretary's Report:**

### **Treasurer's Report:**

Will informed the board that all accounts are liquid and begin contributing money that we have budgeted for scholarships. There is \$1,000 in scholarships from 2016-2017 that haven't been claimed. That unclaimed amount will be removed from the liabilities column, making it available to the Service Account on the Balance Sheet. Will moved that the report be filed as submitted, seconded by Richard Johnson, approved.

### **Old Business:**

#### Information on Community Foundation of Southern Wisconsin and/or the District (WI/UP) Kiwanis Foundation for club donations:

Carl Cramer informed the board of his conversation with Gary Smith from the Community Foundation. Discussion centered on what the club could possibly do with large donations to the club that are designed for the benefit of the club and to help more children. Some of the advantages of investing these donations with a foundation include a tax deduction and maximizing the donations through an investment vehicle that can generate interest. By spending just the interest earned through the foundation, the club would always have a source of funds in perpetuity. There was also discussion on whether we as a club should even consider being part of an endowment. It was decided that more information and discussion is needed before making any decisions.

Twenty eight members and guests enjoyed a tasty Italian House buffet at our annual Valentine dinner.


