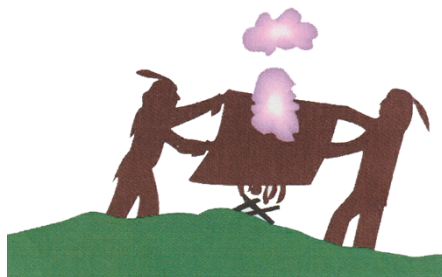

Secretary's Report

BOARD of DIRECTORS Meeting: 11/29/2023

Called to order by President Wilcox at 8:15 a.m.

Paul reported that he is still waiting for Kiwanis International to approve the changes to the bylaws and will make copies as soon as they are available. The minutes were approved as printed in the Smoke Signal.

Treasurer's Report:

Greg reported that the administrative checking is down due to the payment to Kiwanis International of \$5359 for member dues. The service checking is up because of \$5600 of income for Craig/Parker Closet and T.O.I. sponsorship. We paid out \$1900 for Bags of Hope (Janesville Public Schools) Greg said that the NetSuites accounting software is working and that we are required to file an IRS Form 990Z. After the tax filing is done, he will close the books on F2023. After the books are closed, the plan is to make about 6-7 additional donations in December and most of the other donations in January. Greg made a motion to approve

the treasurer's report and was seconded by Richard Johnson and approved.

NEW BUSINESS

Christmas Party:

Roger Willeford gave an update on the Christmas Party entertainment. He said that we could have the same entertainer as last year or we could possibly have a 6 member Parker H.S. Choir plus director perform Christmas carols at the party. After some discussion, Robert Wilcox made a motion to have both for our entertainment and was seconded by Bruce Jorenby. That motion did not pass. The board decided to go with just one entertainment option and Linda Bontly made a motion to go with the Parker Choir and was seconded by Ron Shuler and passed.

Ray Szczepaniak made a motion to donate \$150 to the choir plus meals to each member and their director and was seconded by Bruce Jorenby and passed. If for some reason the Parker Choir option doesn't work out, we will go with the entertainer from last year. In regard to the dinner, if we don't get enough people that desire the turkey option, that option will be dropped.

Craig/Parker Closet:

Jerry Langdok informed the board that representatives from both high schools will attend the Dec. 6th meeting and checks for the amount budgeted and donated from our membership will be presented to them.

Aktion Club:

Linda Bontly made a proposal to the board of paying the dues for the Kandu Industries Aktion Club members. These are people with disabilities and we are now sponsoring this club and this would be a great way of showing our support. Kandu is moving into a different facility in Milton and the amount requested was for \$500. Ray Szczepaniak made a motion to pay for this year only and was seconded by Linda Bontly and approved.

Board Meeting:

The next board meeting will be Dec. 20th at 8:15 a.m. There won't be any regular membership meeting on the 27th of December. Meeting adjourned at 8:55 a.m.

Treasurer's Notes

Administrative Checking: Balance of \$10,784 vs. \$16,117 on Oct 31. The major event was the dues payment to International of \$5359.

Service Checking: Balance of \$48,636 vs \$44830 on Oct 31. We had \$5,600 of income for Craig's Closet and for TOI Sponsorship. We paid our \$1900 for Bags Of Hope (Janesville Public Schools).

NetSuite Accounting Software: NetSuites accounting software is working. Got some help from NetSuites to get automatic downloads from Johnson Bank working. We may be hung up on the two-factor identification. They helped me with a work-around. I will try this for the Nov 30 reconciliation. I am going to do routine reporting for whole months. Beginning a report in the middle of a month can be misleading.

Tax filing: We are required to file an IRS Form 990EZ which is six pages. This meant pulling together specialized reports from the Quickbooks era and the Netsuites era. After the tax filing is done, I will close the books on F2023

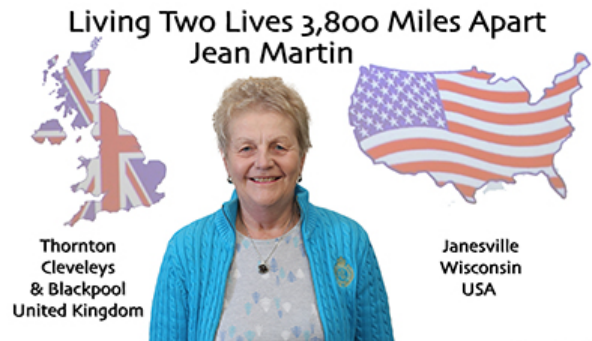
