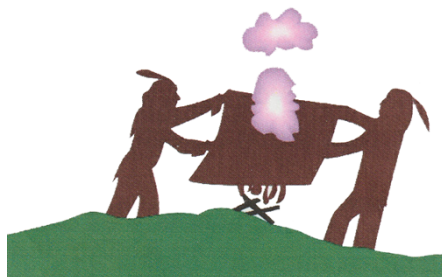

BOARD of DIRECTORS Meeting: 09/27/2023

Call to Order: 8:15 a.m. by President Jorenby

Secretary's Report:

Minutes were approved as printed in the Smoke Signal.

Treasurer's Report:

The treasurer's report showed an increase of \$69 to the administrative checking account due to the collection of \$708 in dues with expenses that included \$320 in free t-shirts, \$176 for the post office box and \$403 for rent and refreshments. The service account checking was up \$110 from last month. Greg made a motion to approve the treasurer's report as filed and was seconded by Roger Willeford and approved.

BUDGET

Greg went over the 2024 budget that was approved on 7/26/23 for any possible changes before the writing of checks begins. The miscellaneous expenses in the administrative account budget were increased from \$30 to \$180. The peanut day donation of \$100 was eliminated.

Carl Cramer made a proposal to award two Hixson awards this year. Kiwanis International requires a \$1000 donation to the Kiwanis Children's Fund to be eligible for this award. The club had already budgeted for one award and it was suggested that we could move \$1000 from the administrative account to the service account for this purpose. Carl's motion was seconded by Tom Neumann and approved. Lonnie Coppernoll made a motion to approve the budget as presented to the board and was seconded by Roger Willeford and approved.

BYLAWS

Linda Bontly went over the changes to the bylaws for the board's final approval before submission to Kiwanis International. The changes included the removal of Peanut Day as a fundraiser and the removal of Kiwanis One Day. Until further notice, the Lincoln K Kids program has been eliminated from our school projects and the Aktion Club at Kandu has been added for the purpose of being a liaison between mentally and physically challenged children and adults.

Bingo at Rock Haven was removed from the service projects. Bruce Jorenby made a motion to approve these changes and they were seconded by Ron Shuler and approved.

SPONSORSHIPS

John Janes stated that in addition to the current sponsors for Truck on Ice, contacts were made to the sponsors of the Kiwanis Noon Club projects in the hope of raising more money for our signature Truck on Ice fundraiser.

Meeting adjourned at 8:52 a.m.

Sunday, April 23—start set up 7 am loading. Arrive 7:45. Set up in front of Rotary Gardens by 8:30. Steady sales all day. Temp 35-40 and overcast. Last sale at 3:50. All trees fit in refrigerated trailer at end of day.

Friday, May 5—start at 7 am. Set up at Rotary Gardens Horticultural building. 2 long tables plus 1 card table.

Ready to start by 8:30. Packaged pre-orders, selling by 8:45. Temperature was 72 with light breeze. Very busy on first shift with plenty of help. Second shift was slower and third shift was slow. 400 trees plus pre-orders left. May 6—start at 8 am. Temperature 56 and misty rain. Set up by 9. Slow sales and pre-orders were not being picked up. Called people to remind them. All left over pre-order trees went on sale at noon. Sold everything by 2.

Refrigerated trailer was picked up and everything was packed by 2:30. Returned home, made Sold Out Sign to place at Rotary Gardens. Picked up 4 large signs from locations in Janesville.

Problems—pre-order tags. We could have sold 300 to 400 more trees. Cut back on Oak. Add Arborvitae and Black Hills Spruce.

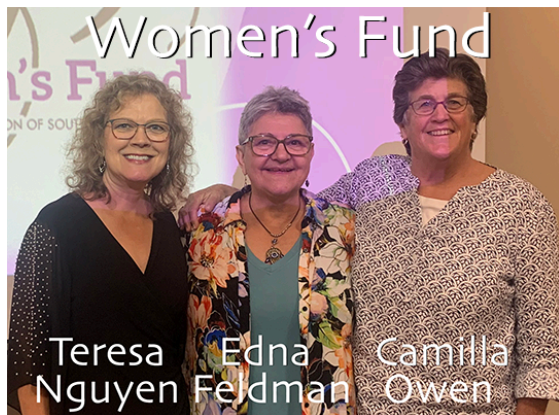


Kiwanis member Mel – Tour dates to follow
